

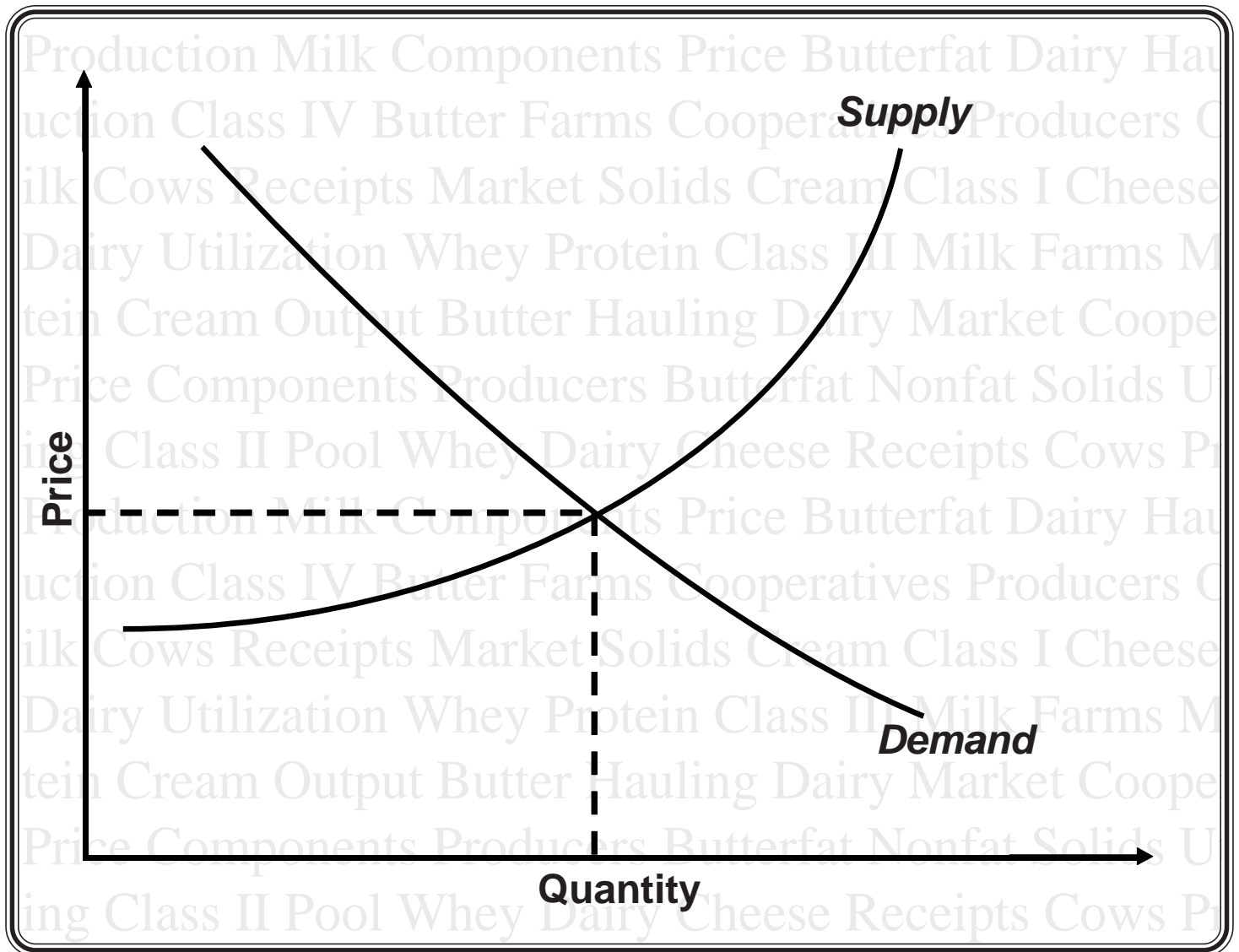

Summary

This bulletin provides information about the operation of the Northeast Order during 2008 through a series of tables and charts. The *Bulletin* Highlights section summarizes important events that impacted the dairy industry in 2008. Also included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

Producer Milk Receipts Increase

During 2008, the volume of milk received from producers shipping to handlers regulated under the Northeast Order totaled 23.9 billion pounds, a significant increase of 3.4 percent from 2007. Some of this growth was due to milk production increases, while also impacted by pooling changes that resulted in some milk previously pooled on another federal order or not pooled by any federal order being pooled back on the Northeast Order. During 2008, milk production responded to the record-setting prices in 2007. Nationally, milk production increased about 2.0 percent from 2007 levels. In the Northeast, production grew about 1.0 percent. Due to inverted prices (when the Class III price is higher than the Class II and IV prices) during May and June, some milk was depooled during those months (approximately 300 million pounds). Even with the depooling, total pooled receipts on the Order increased 3.4 percent from 2007. All volume comparisons were adjusted for leap year.

The year ended with 490 fewer producers than in 2007. Annual average daily deliveries per producer (DDP) equaled 4,807 pounds, up 5.7 percent from 2007.

Class Utilization Changes

Class I utilization averaged 43.4 percent in 2008, a decrease of 2.1 percentage points from the previous year. The total volume of milk used in Class I decreased 1.3 percent. Sales of whole milk, flavored milk and drinks, buttermilk, and eggnog declined, while reduced fat (2%) and lowfat (1%) increased. Sales of fatfree (skim) were relatively flat; sales by plants regulated under the Northeast Order into other federal orders and areas not regulated by any federal order decreased. Class II usage declined 1.7 percent, resulting in a decrease in utilization of 1.0 percentage point and an overall pool utilization of 19.5 percent. Milk used to make Class II products such as cottage cheese, ricotta cheese, sour cream, and yogurt decreased, while milk used in ice cream increased.

Class III volume was down 5.9 percent with a drop in utilization of 2.2 percentage points. Class III usage averaged 22.3 percent, the lowest ever. Milk used to make Class III products such as American and Italian cheeses decreased; milk used in cream cheese and Swiss cheese rose during 2008. The amount of milk used in Class IV jumped 61.6 percent in 2008; utilization rose 5.3 percentage points and accounted for an annual

average of 14.8 percent for the year, the highest ever. Most of the increase was in milk used to make nonfat dry milk, the result of record high prices and strong demand for nonfat dry milk and changes in processing plant activity (closures, temporary down time).

Prices Lower

The increases in milk production that occurred during late 2007 and early 2008, along with a slowing world economy, reduced prices as the year progressed. For the year, all federal order class prices averaged less than during 2007, some with double-digit declines.

The Class I price averaged \$21.25 per hundredweight in 2008, 14 cents (0.7 percent) below the 2007 annual average. Class I prices were record-setting for the months of January through April. The Class II price averaged \$2.12 less (11.5 percent) than the previous year, while the Class III price declined 60 cents (3.3 percent) from 2007. The Class IV price was hit the hardest, averaging \$3.71 per hundredweight (20.2 percent) less than the 2007 average.

Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston) averaged \$18.62 per hundredweight, \$1.23 (6.2 percent) less than the 2007 annual average, but still the second-highest blend price on record for the Order. The producer price differential (PPD) averaged \$1.18 per hundredweight, 34.8 percent less than the average in 2007 and the second lowest average PPD since the Order's inception. The PPD was negative at all zones reported during 3 months of 2008, the highest number of times since the Northeast Order began.

Component Pricing

The price paid to producers for butterfat averaged \$1.5668 per pound, 6.6 percent higher than in 2007, and making it the third highest annual average butterfat price since the Order's inception. The per-pound annual average protein price was \$3.8898, up 10.8 percent, topping 2007's record-setting price of \$3.5121 per pound. The other solids price dropped 86.8 percent, from \$0.4201 to \$0.0555 per pound. Negative other solids values were reported during the last 3 months of 2008. The nonfat solids price declined 30.7 percent, from \$1.5218 to \$1.0552 per pound, but was still the second highest on record.

Producer Tests

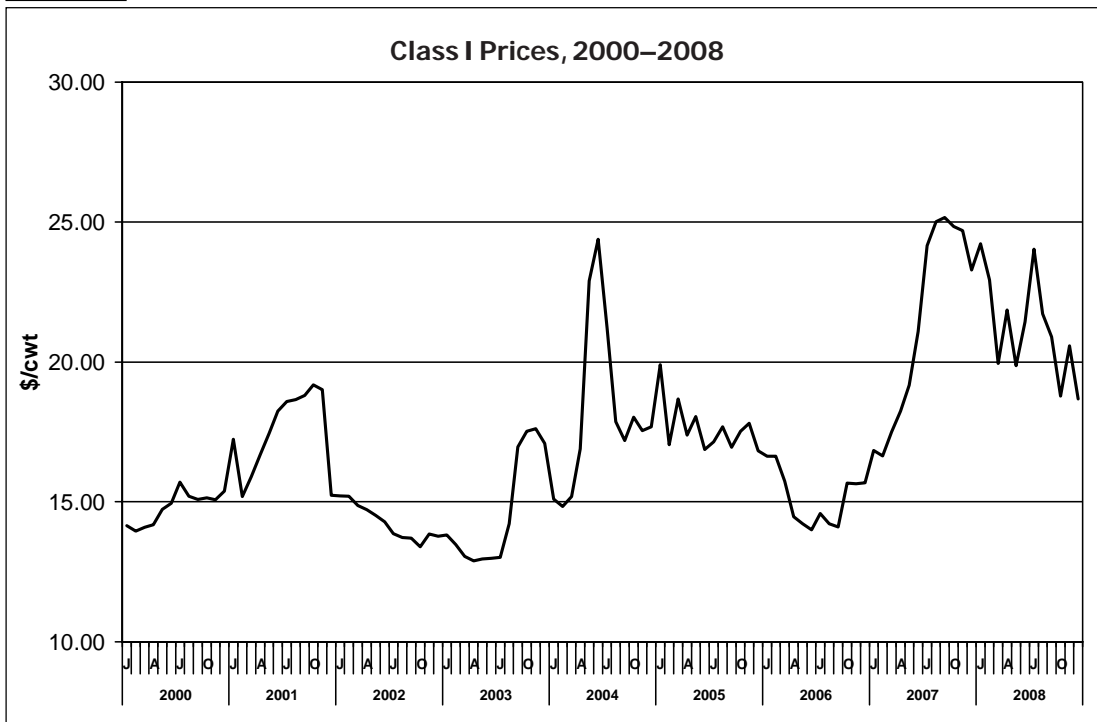
The annual average producer butterfat test increased from 3.70 percent in 2007 to 3.73 percent in 2008. During 6 of the months, butterfat tests set new record highs for the corresponding month. Both the producer protein and other solids tests averaged the same as in 2007, 3.06 and 5.71 percent, respectively. The protein test set new record highs 5 of the months, while the other solids test was record-setting high during 3 months of 2008.

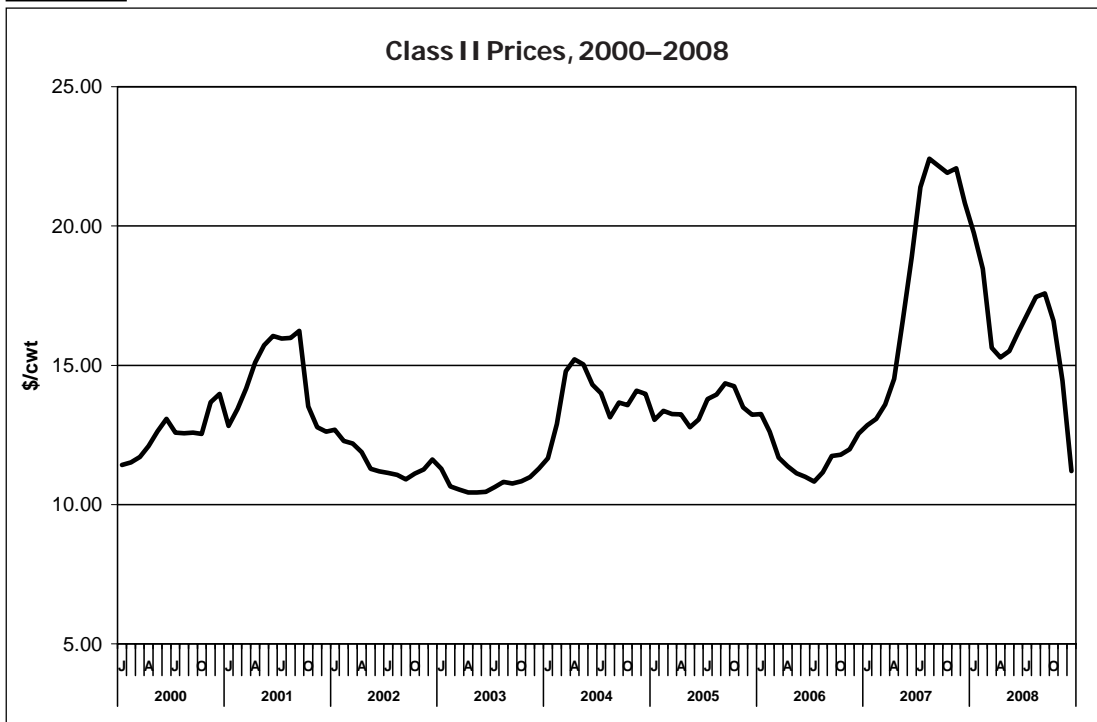

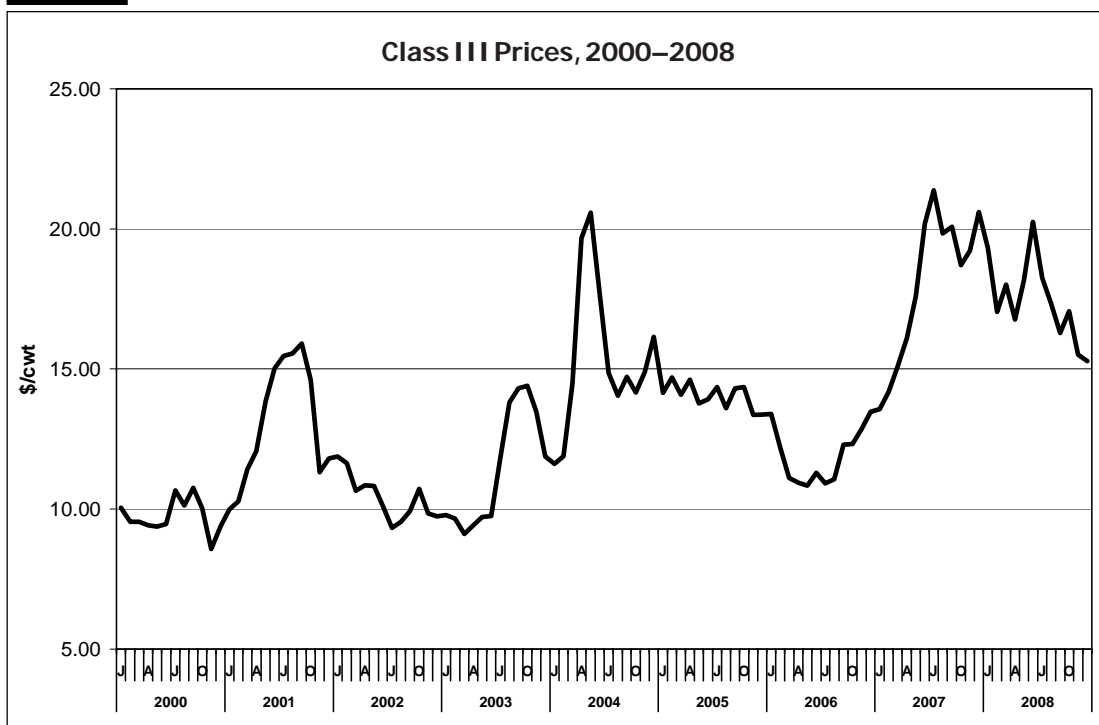

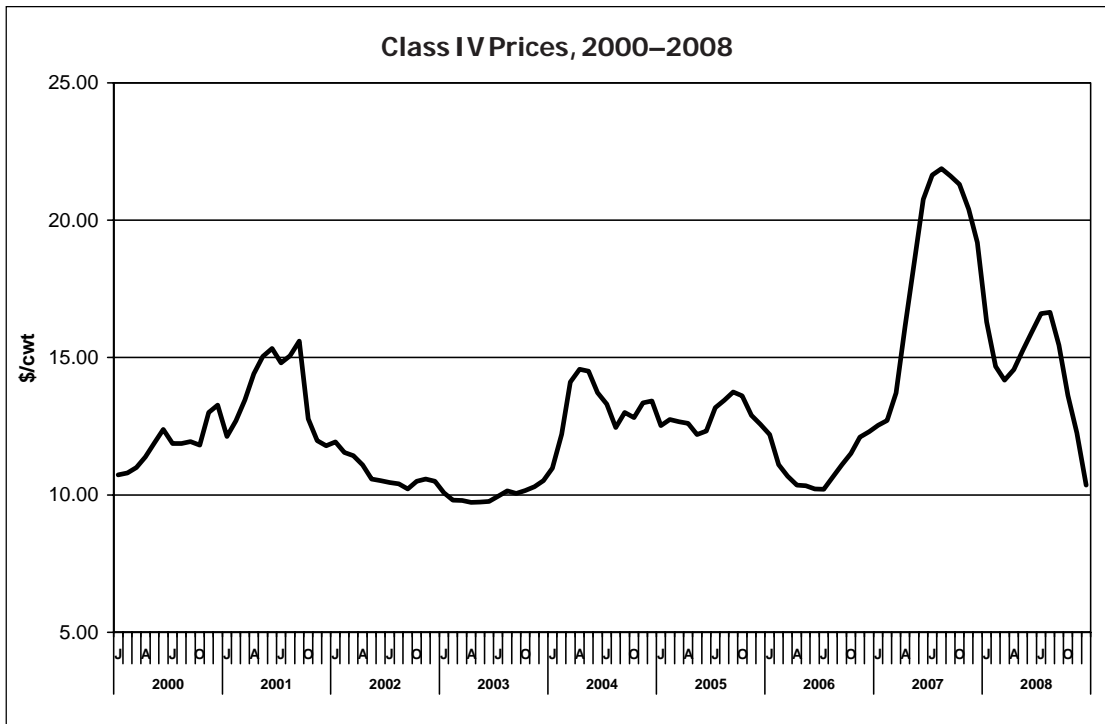

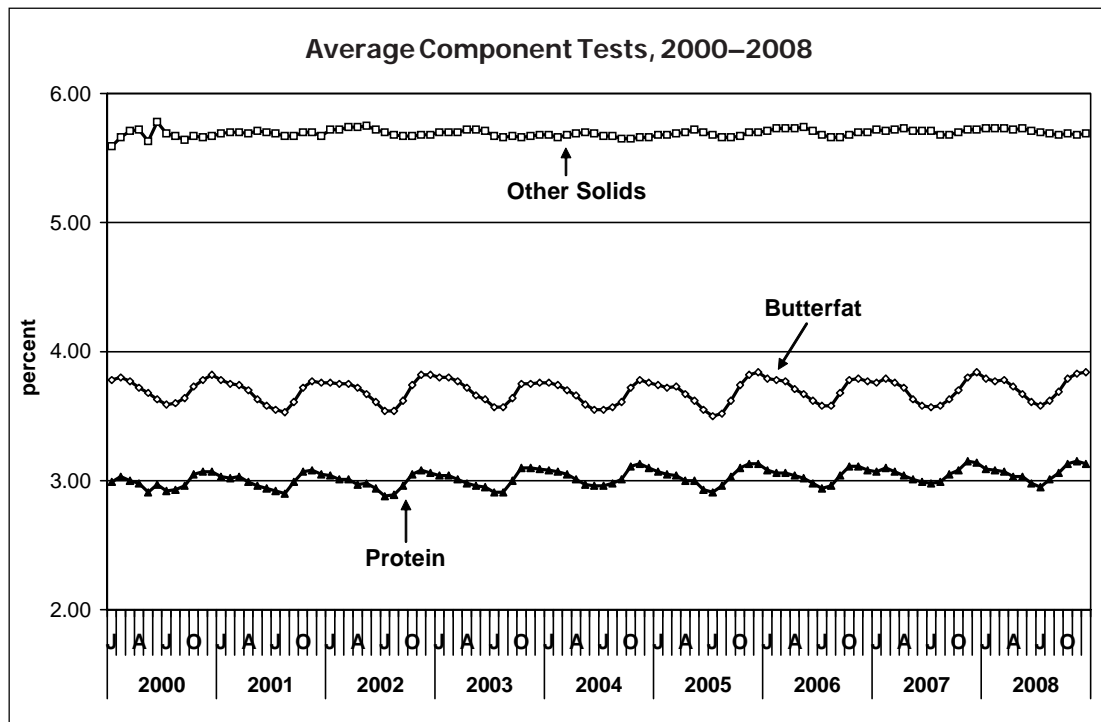

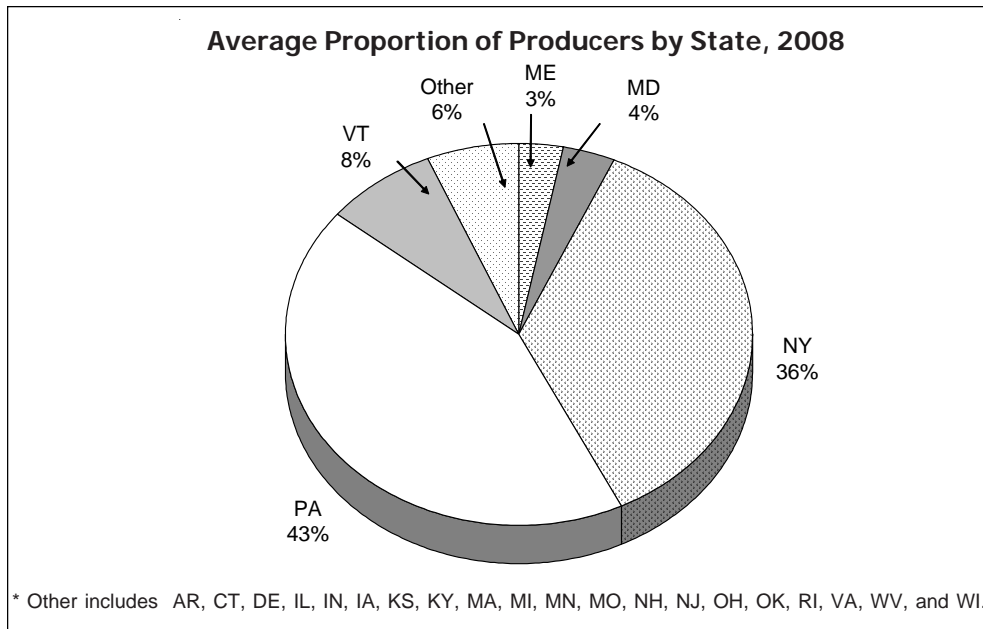

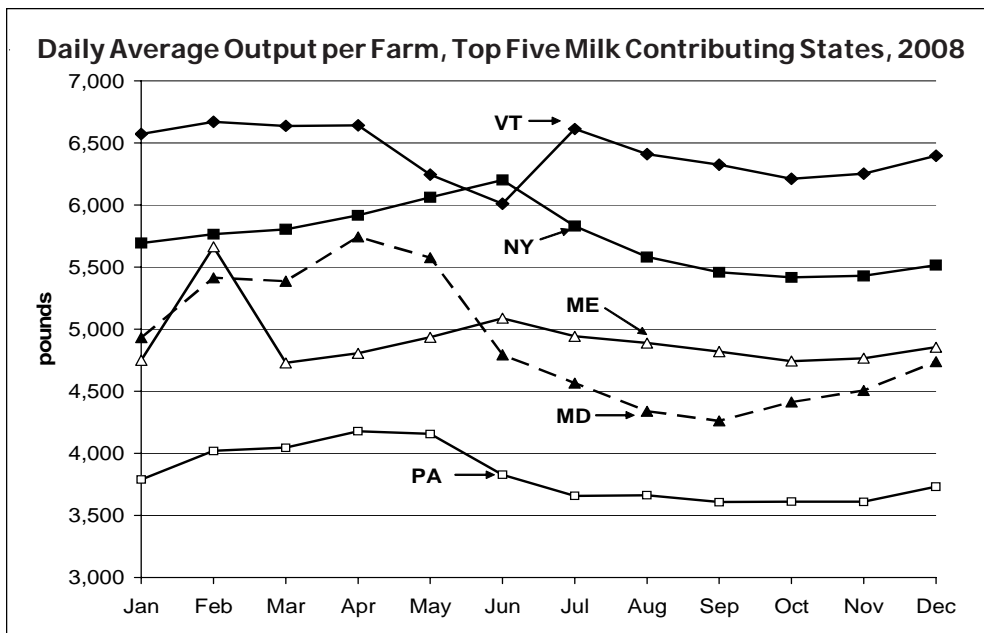

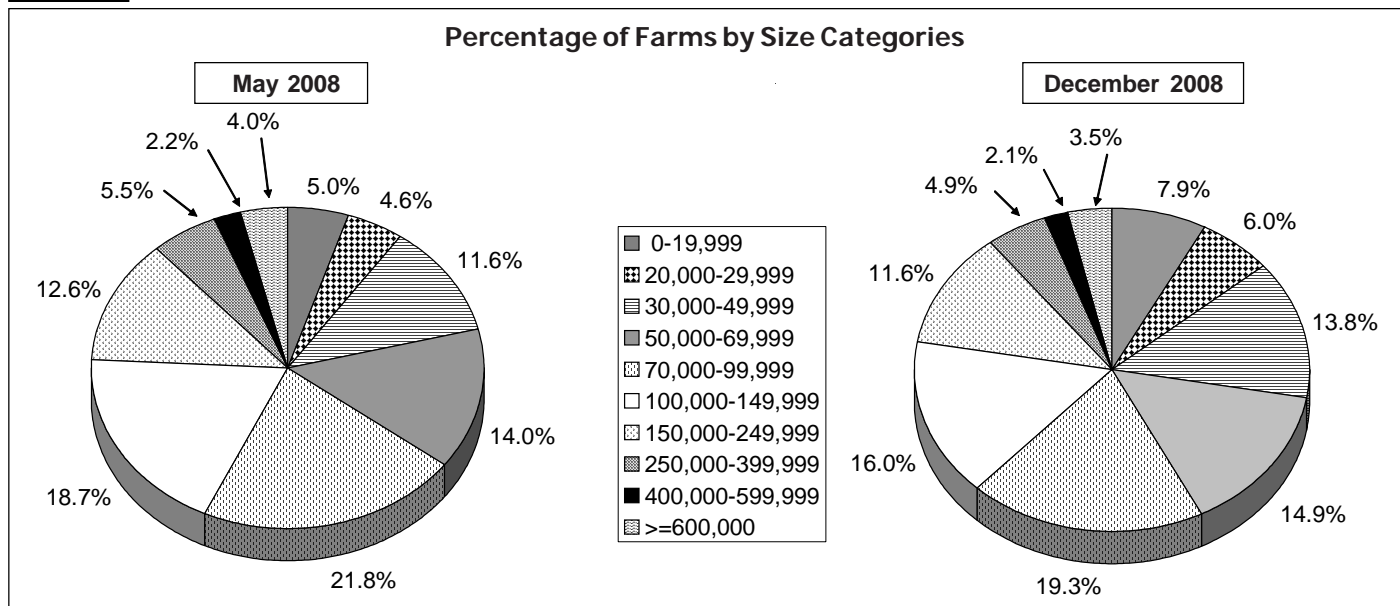

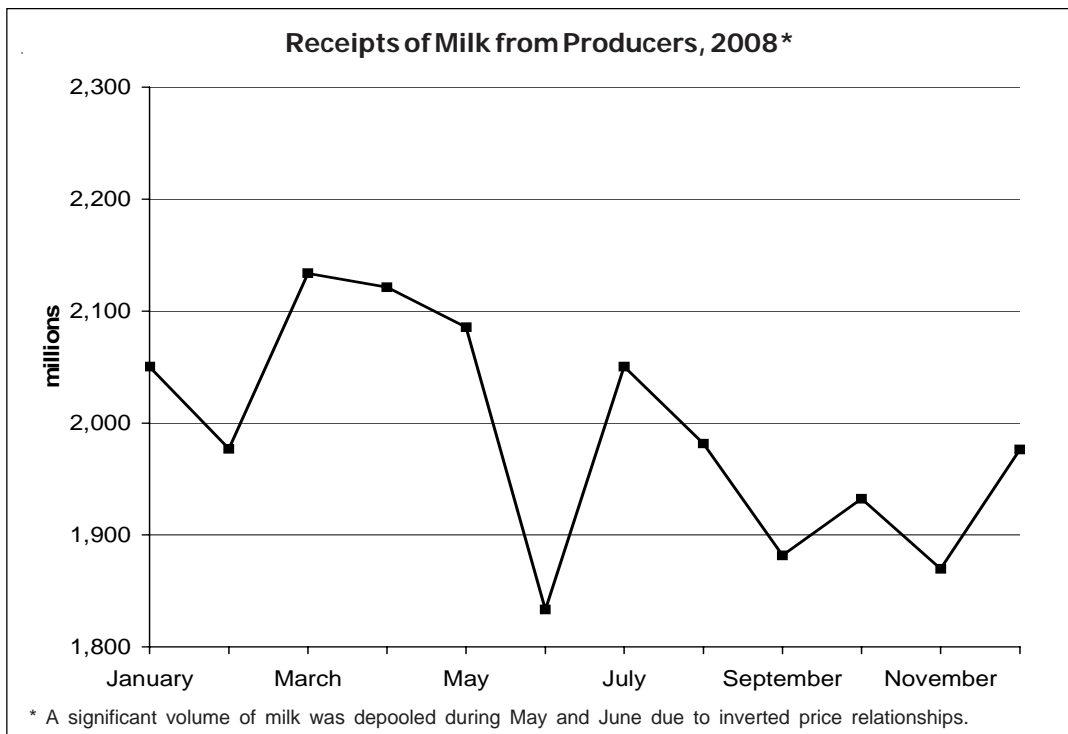

Bulletin Highlights—2008

January

The market service department checked 489 farm bulk tanks throughout the Northeast Marketing Area milkshed during the 2007 season. An accompanying table illustrated the 2007 tank calibration work by tank size.

Sales of Class I fluid milk products for 2007 in the Northeast Milk Marketing Area totaled nearly 9.3 billion pounds, a decrease of 0.3 percent from 2006. Volume and percent change information for 2006 and 2007 were shown in a table while a chart illustrated per capita sales by product for 2007.

U.S. Milk production registered an increase of 2.1 percent in 2007.

February

USDA issued a tentative final decision that would, among other changes, increase Class I prices and adjust the Class I pricing surface of the Appalachian, Southeast, and Florida marketing orders.

The Northeast uniform price moderated from the record high levels that occurred during the second half of 2007. Accompanying charts illustrated actual and projected Northeast Order uniform prices for 2007 through 2008 and the number of milk cows in the top 23 states for January 2007 through January 2008.

The number of producers by size of milk marketings for December 2007 was compared to December 2002. Two tables showed the number of farms by pooled pounds and farms marketing more than 1.5 million pounds per month, by state, for December 2007.

A pool summary for all federal orders was given in a table for January–December, 2006 and 2007.

March

The Northeast Order's producer price differential was negative for all zones in March 2008 for the first time since May 2004.

The results of the November 2007 biennial container sales survey for the Northeast Milk Marketing Area were reported. Charts illustrated sales by container size and product type.

The Northeast Milk Marketing Area announced the tentative calibration truck schedule for 2008.

A pool summary for all federal orders was given in a table for January–March, 2007 and 2008.

April

The 2007 total volume of Class I sales sold in the Northeast Marketing Area by handlers not designated as pool distributing plants under the Order increased 8.2 percent from the previous year. A table compared

the Northeast Order in-area route sales by handler type for 2002, 2006, and 2007.

USDA released their *Dairy Products 2007 Summary*, a publication reporting dairy products manufactured in the United States. A table showed selected U.S. manufactured dairy products for 2006 and 2007.

The milk-feed price ratio in April 2008 dipped to the lowest level since January 1985. Charts illustrated the Northeast Order blend price versus the milk-feed price ratio for January 2007–April 2008, including estimates for May–December 2008.

May

USDA issued a tentative partial final decision to amend the manufacturing allowances contained in the Class III and Class IV product price formulas applicable to all federal milk marketing orders. It was published in the June 20 *Federal Register*.

The contribution to the producer blend price by components was discussed and accompanied by a table showing the contribution by component for the month of May for 2004, and 2006 through 2008, using a hypothetical farmer producing 100,000 pounds of milk at the pool average component tests during that month.

Both the Senate and House of Representatives voted to override the President's veto of the 2008 Farm Bill. An overview of the dairy section of the bill was given.

USDA issued a final rule adopting amendments to the Dairy Products Mandatory Reporting Program established on August 2, 2007.

June

An explanation of the referendum and rule making process was given on why two referendums were held on the amended Northeast Milk Marketing Order changes to the Class III and Class IV make allowances and the butterfat yield factor. A chart illustrated the decision process for the amendments.

Even though the producer price differential for June 2008 was negative for all zones of the Northeast Order, the statistical uniform price was the highest since January 2008. A chart showed the Northeast Order statistical uniform price for 2007–2008.

A pool summary for all federal orders was given in a table for January–June, 2007 and 2008.

July

USDA released an interim final rule amending the Class III and Class IV product price formulas in all federal milk marketing orders effective September 1, 2008.

Milk production in the U.S. was up 2.4 percent for the first 6 months of 2008, compared to an increase of 1.0 percent for the same time period last year. A map showed the year-to-year percent change of milk production in the top 23 milk producing states for the first 6 months of 2008.

An explanation was given on why commodity prices for cheese have been changing, dramatically increasing and decreasing significantly within the same week, on the Chicago Mercantile Exchange.

The 2008 Farm Bill extended and strengthened the Milk Income Loss Contract (MILC) program through August 31, 2012. An explanation of how the added feed cost adjustor works was given accompanied by a table of the MILC base trigger price with the feed cost adjustor for the 2008 fiscal year.

August

The USDA issued a statement delaying the implementation of the interim final rule amending the Class III and Class IV product price formulas in all federal milk marketing orders. The effective date of September 1, 2008, was moved to October 1, 2008.

Average component tests in the Northeast Marketing Area were compared with charts illustrating producer butterfat, protein, and other solids prices and tests for 2007–2008 versus 2001–2008 averages.

Notable changes occurred in how milk pooled on the Northeast Order had been utilized in the respective classes. Utilization rose 5.4 percent for January through June 2008 compared to the same period of 2007. A table showed utilization for select products for January–August 2008.

September

The Commodity Credit Corporation purchased nonfortified nonfat dry milk during the week of October 6–10, the first time since July 2006.

An explanation was given on why the October 2008 Class I price declined \$2.12 per hundredweight below September's price. A chart illustrated the Northeast Order Class I and statistical uniform prices for January–October 2008 and estimated prices for November 2008–December 2009.

A pool summary for all federal orders was given in a table for January–September, 2007 and 2008.

An explanation of how Northeast mailbox prices vary by region was given. Charts illustrated total pounds of milk delivered by region and differential zone delivered to for June 2008 and mailbox prices by regions within the Northeast for January 2007–June 2008.

October

USDA announced a final rule establishing the Dairy Forward Pricing Program directed by the 2008 Farm Bill allowing milk producer and cooperative associations to voluntarily enter into forward price contracts with milk handlers for milk used for non-fluid purposes. A list of the program rules was given.

For the first time since July 2003, the October 2008 other solids price was negative. An explanation was given for how the price was calculated along with a chart illustrating dry whey and other solids prices for January 2007–October 2008.

Class IV utilization for October 2008 was 223.3 million pounds, setting the highest record since the Northeast Order's inception.

For the first ten months of 2008, daily deliveries per producer increased an average of 217 pounds compared to the same time period last year, setting the largest gain recorded since the Order's inception.

James E. Link was appointed as Administrator of the Agricultural Marketing Service.

November

An explanation was given on how declining demand and exports impact milk prices. A chart illustrated the commodity prices for 2007–2008.

The 2008 Northeast Regional Dairy Outlook Conference was held on November 20 at the Northeast Order's Albany office. A table showed the statistical uniform prices for 2007, the actual and estimated prices for 2008, and the estimated prices for 2009.

A calendar showed the 2009 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

December

The Milk Income Loss Contract (MILC) program, which was extended through August 2012 in the 2008 Farm Bill, expected to pay out payments for the first time since February 2007 because of declining commodity prices contributing to falling milk prices. A table illustrated estimated MILC program prices for February 2009, in comparison with January 2009.

The Milk Price Support Program was renamed the Dairy Product Price Support Program under the 2008 Farm Bill. The new program was changed to support the price of *dairy products* instead of the price of *milk*. Details of the new program were explained.

Selected Northeast Order statistics for 2008 were summarized and a table compared the Order's pool statistics for 2007 and 2008.
