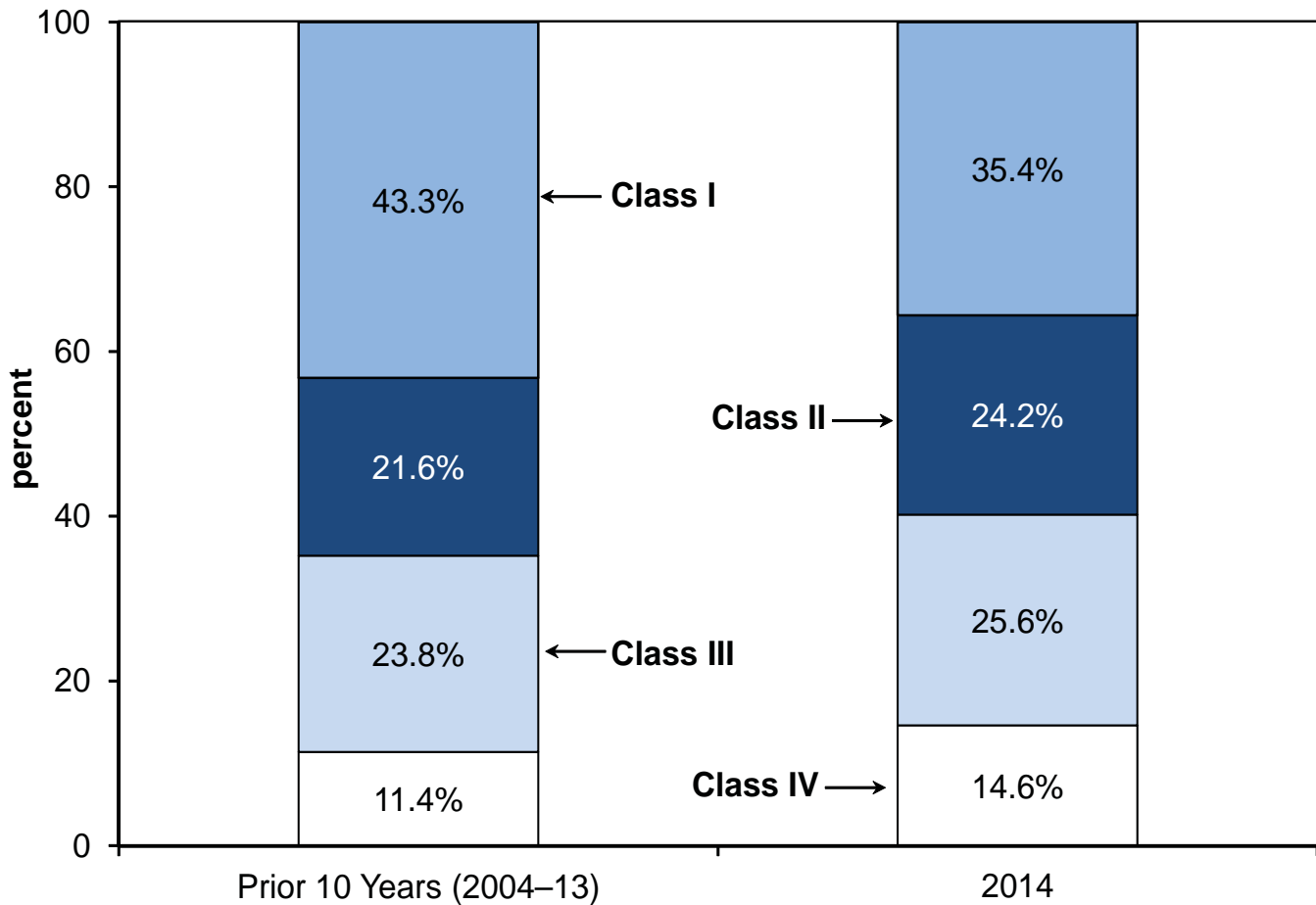

Summary

This bulletin provides information about the operation of the Northeast Order during 2014 through a series of tables and charts. The *Bulletin* Highlights section summarizes important events that impacted the dairy industry in 2014. Also included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

Producer Milk Volume Sets New Record

During 2014, the volume of milk received from producers shipping to handlers regulated under the Northeast Order set a new record high since the Order's inception in 2000, surpassing last year's record-setting volume by 1.5 percent.

Nationally, total milk production rose 2.4 percent in 2014, up considerably from the 0.6 percent increase in 2013. Production in the Northeast milkshed increased at a lower rate, 1.7 percent. The main contributing states (New York, Pennsylvania, and Vermont) combined had the same increase as the milkshed total; milk pooled on the Order from these three states grew 1.6 percent in 2014. Milk pooled on the Order from outside the milkshed (Indiana, Kentucky, Michigan, Minnesota, Ohio, and Wisconsin) rose 6.9 percent, but represented only 0.6 percent of total pooled milk receipts.

The year ended with 91 less producers than at the end of 2013. Annual average daily deliveries per producer (DDP) equaled 5,813 pounds, an increase of 3.1 percent from 2013 and a new record on the Order.

Class Utilization Changes

Class I utilization averaged 35.4 percent in 2014, a decrease of 2.0 percentage points from the previous year. The total volume of milk used in Class I continued its decline, dropping 4.0 percent, and resulted in the smallest ever for the Order. Class II usage decreased 5.0 percent, resulting in overall utilization of 24.2 percent, down from 25.9 percent in 2013.

Class III volume rose 3.2 percent with utilization averaging 25.8 percent, up 0.4 percentage points from the previous year. The amount of milk used in Class IV jumped 30.5 percent and accounted for an annual average utilization of 14.6 percent, up 3.3 percentage points. The total volume used in Class IV set a record high for the Order; significant increases were reported in milk used in nonfat dry milk.

Record-setting Prices

Prices for all commodities used in calculating

minimum federal order prices not only rose during 2014, but set record highs. Butter finished the year with a \$2.1361 per pound average price after topping \$3.00 per pound for the first time ever in mid-to-late September on the Chicago Mercantile Exchange (CME) and in early October as reported by the National Dairy Products Sales Report. Cheese prices averaged over \$2.00 per pound for the first time and, as mentioned above, nonfat dry milk and dry whey also reported record high annual averages.

During 2014, the Class I price averaged \$26.54 per hundredweight (cwt) in 2014, \$4.45 (20 percent) above the 2013 annual average. The Class II price averaged \$23.34 per cwt, \$3.92 and 20 percent higher than the previous year. The Class III price averaged \$22.34, up \$4.35 and 24 percent from 2013. The Class IV price rose \$3.04 to \$22.09, an increase of 16 percent. For the first time under the Order, all class prices averaged over \$20 per cwt!

Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston), averaged \$24.28 per cwt, the highest since the Order's inception, and \$4.03 and 20 percent higher than the 2013 average.

Component Pricing

High commodity prices translated into record, or near-record, high component prices and record-high class prices. The price paid to producers for butterfat averaged \$2.3792 per pound, 43 percent higher than in 2013. The per-pound annual average protein price was \$3.7935 per pound, up 15 percent from 2013. The other solids price rose 16 percent and averaged \$0.4684 per pound. The nonfat solids price averaged \$1.5844 per pound, an increase of 4 percent. Prices for producer butterfat, other solids, and nonfat solids were the highest ever reported for the Order; the protein price was the second-highest ever, surpassed only by the average price in 2008.

Producer Tests

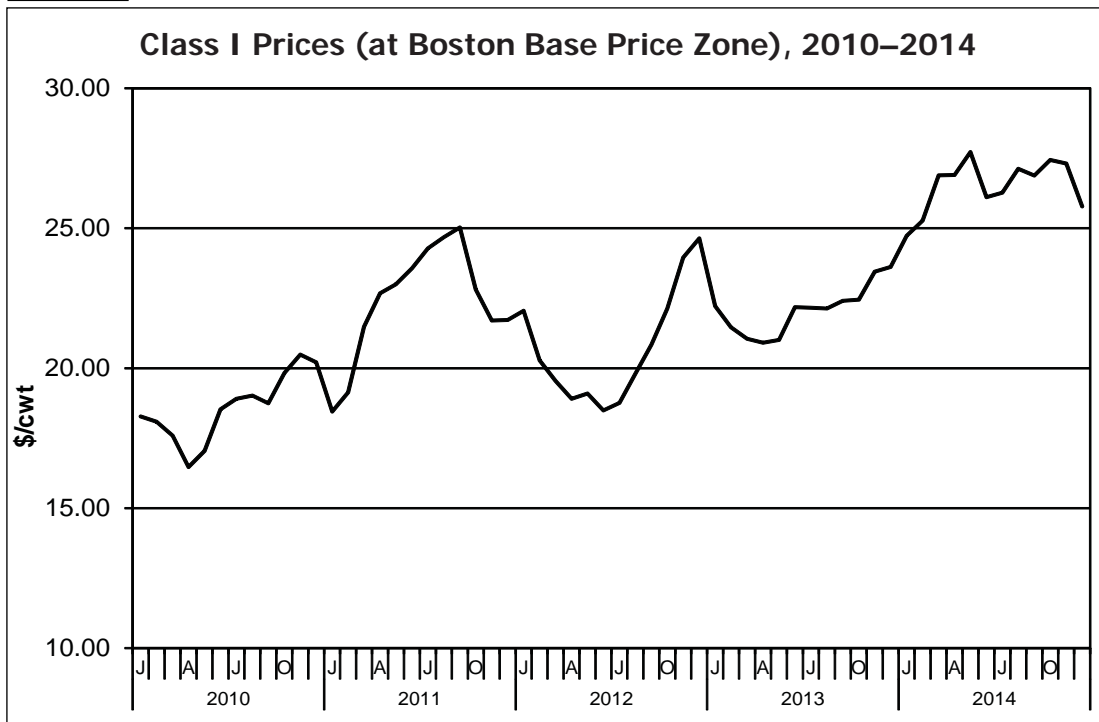
The annual average producer butterfat test equaled 3.78 percent in 2014, up 1 percentage point from last year, and set a new record. Records were set during 6 months and tied in 5 months. The annual average producer protein test was 3.08 percent, unchanged from 2013 and also tied with last year's record-high. Records were set in 4 months and tied in 2 months during the year. The producer other solids test averaged 5.73 percent, also unchanged from 2013 and tied for second highest annual average.

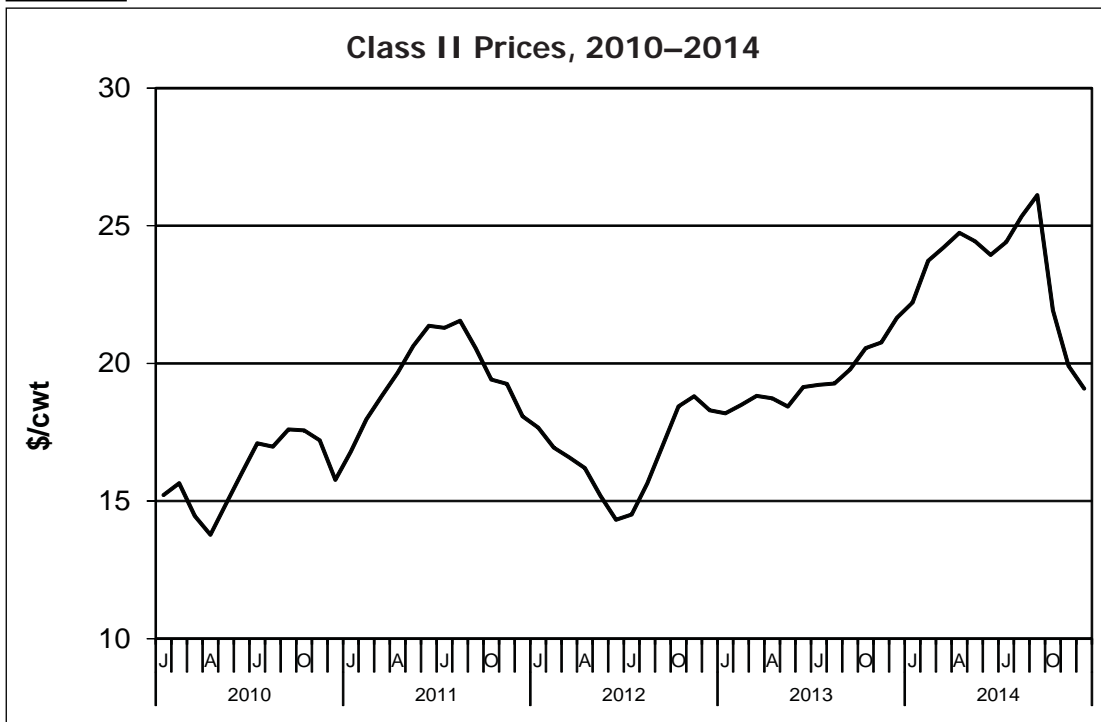

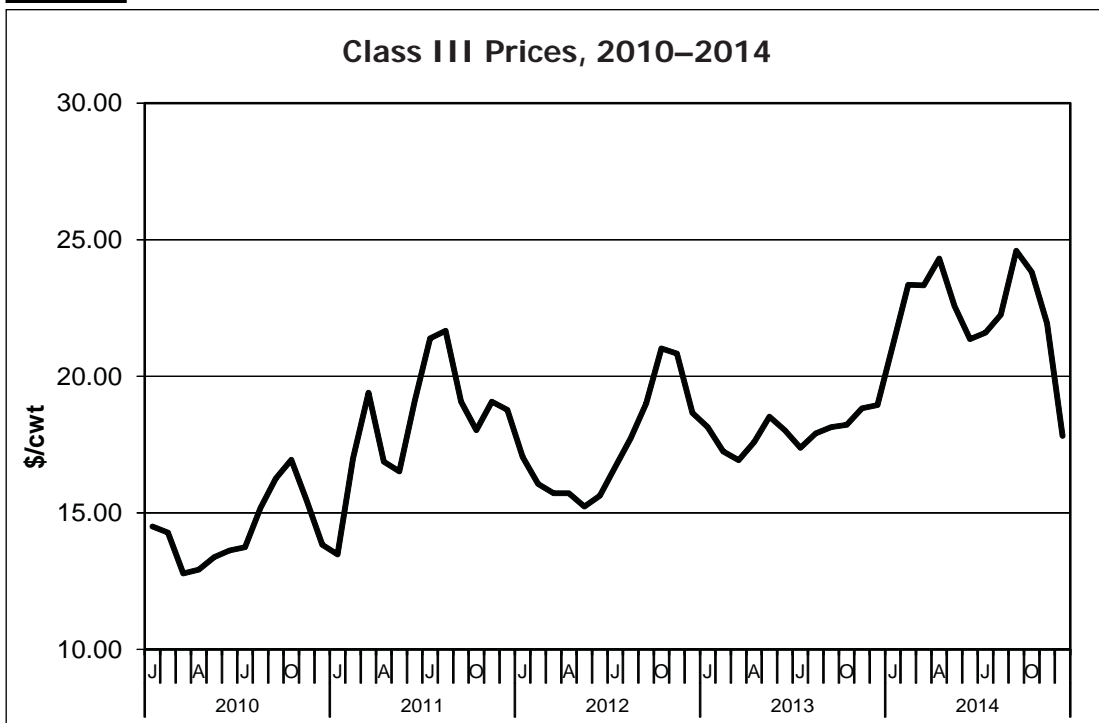

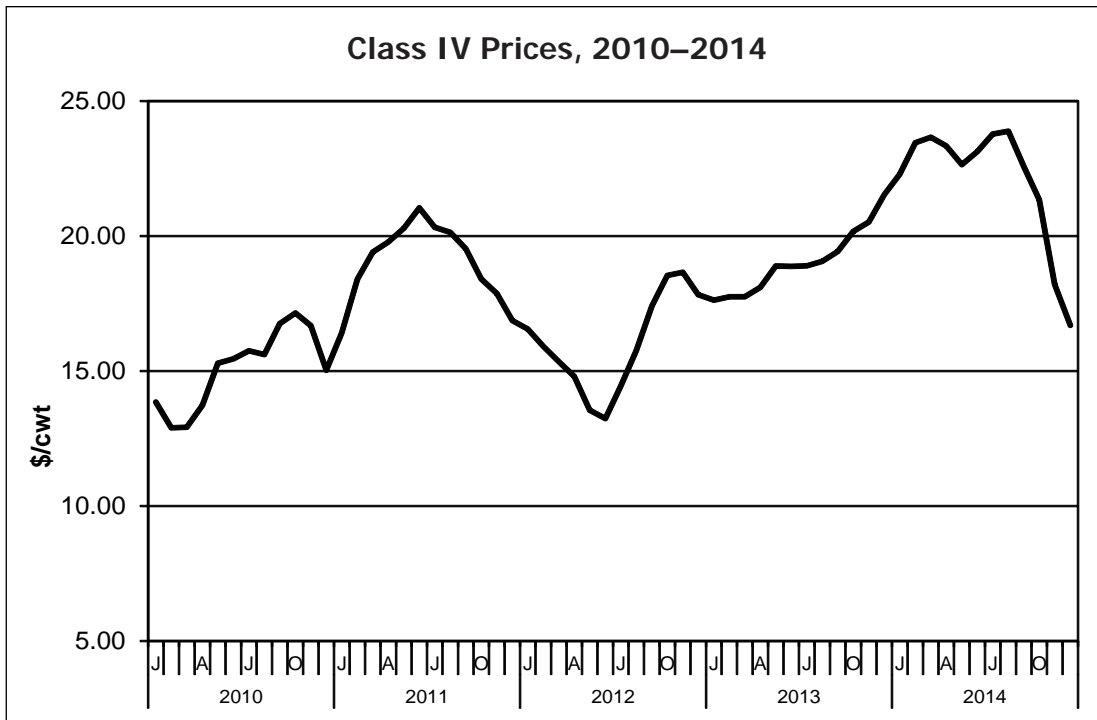

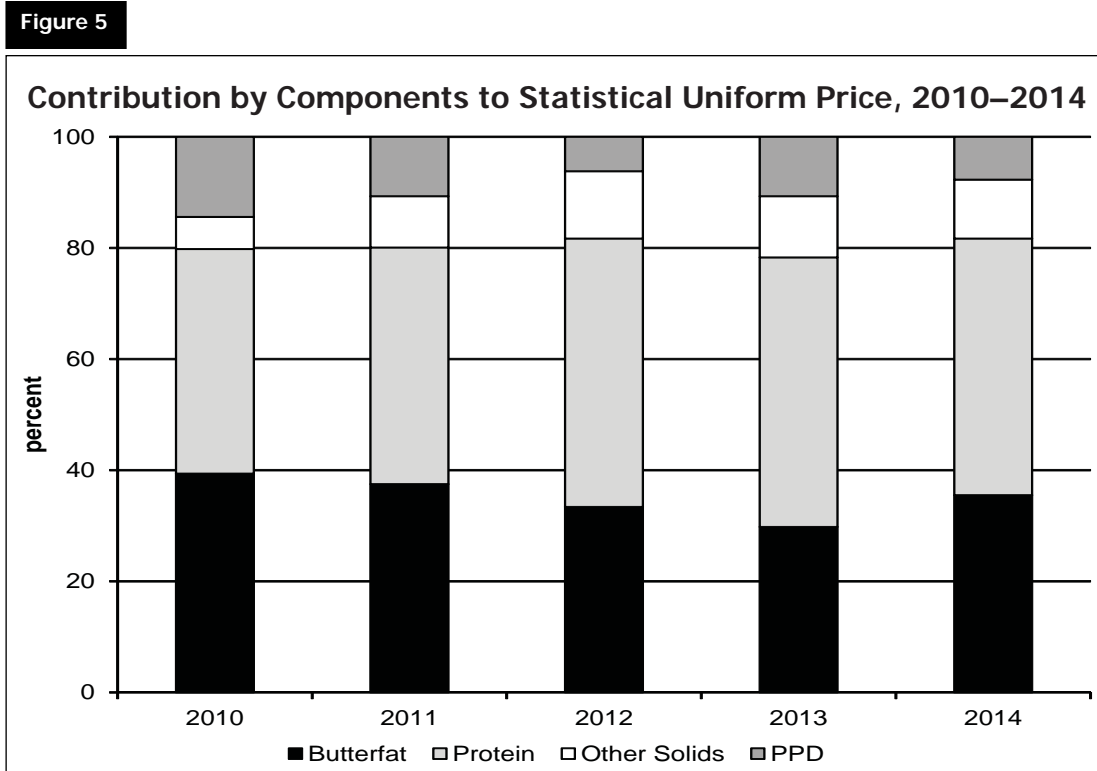

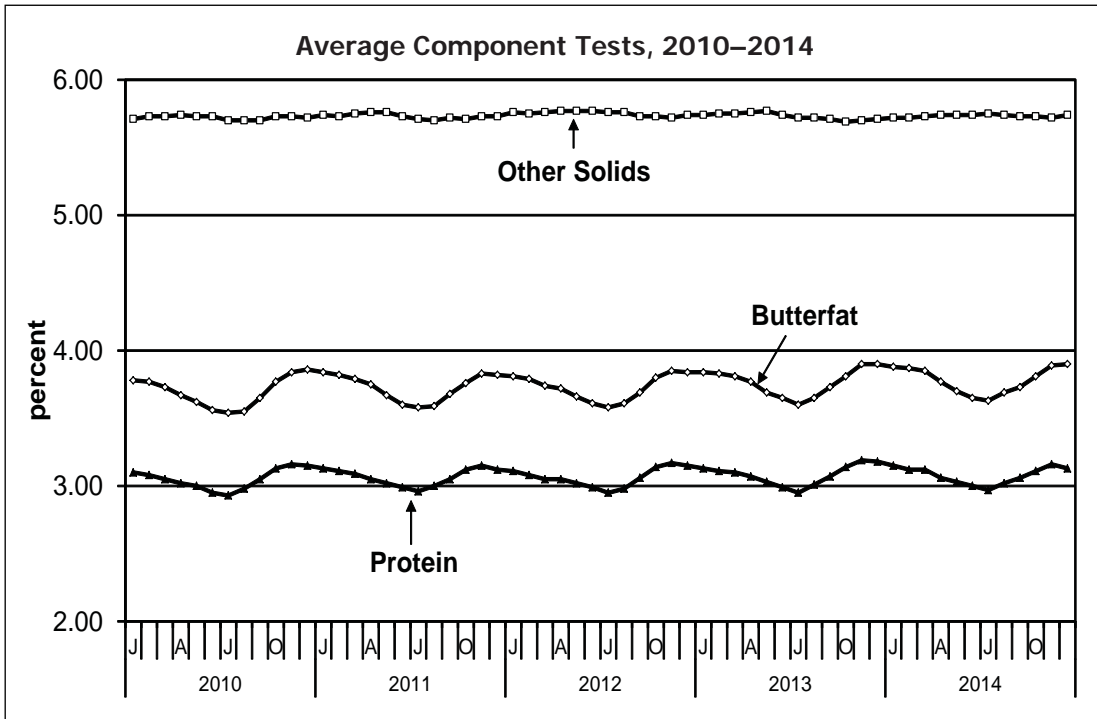

9 Receipts of Milk from Producers, by State*, 2014

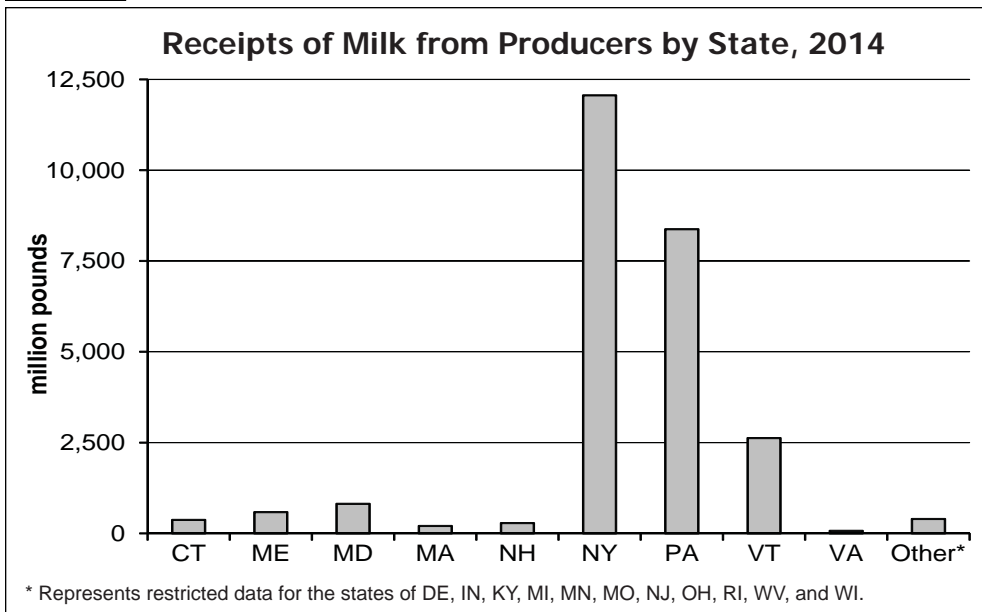

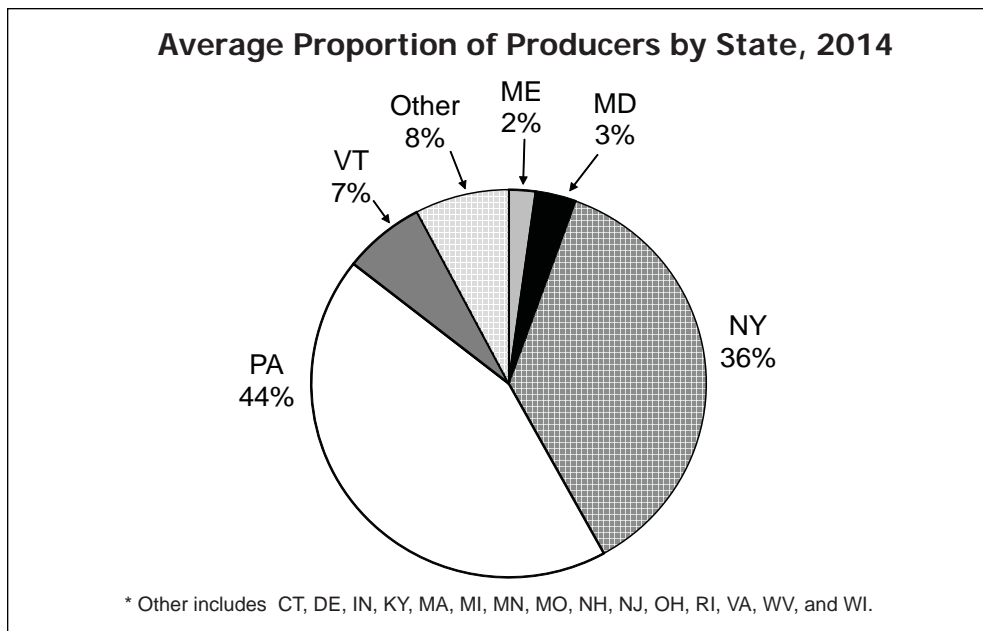

11 Daily Average Output of Producer Milk per Farm, by State*, 2014

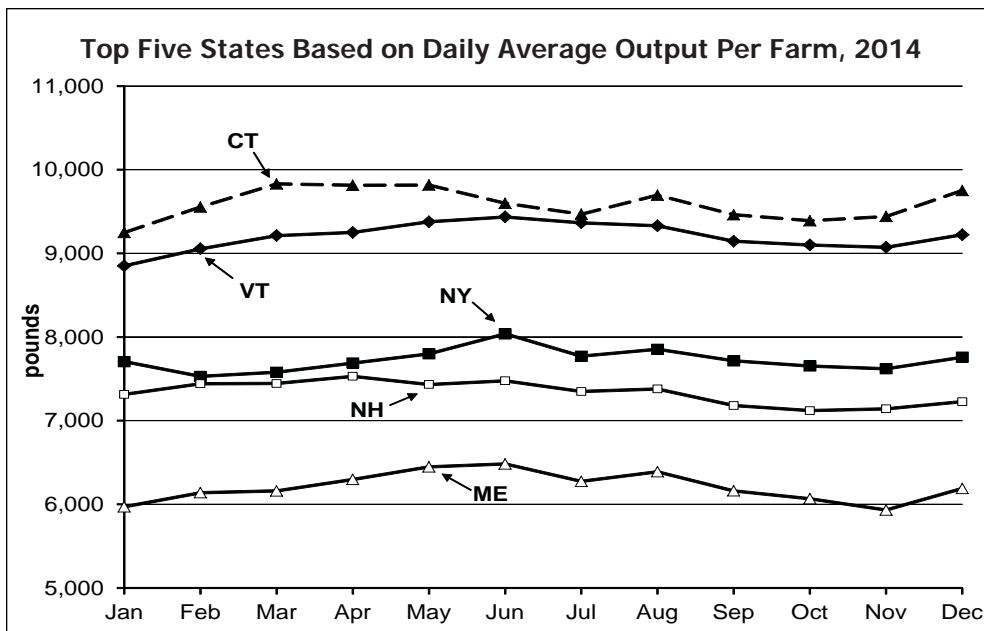

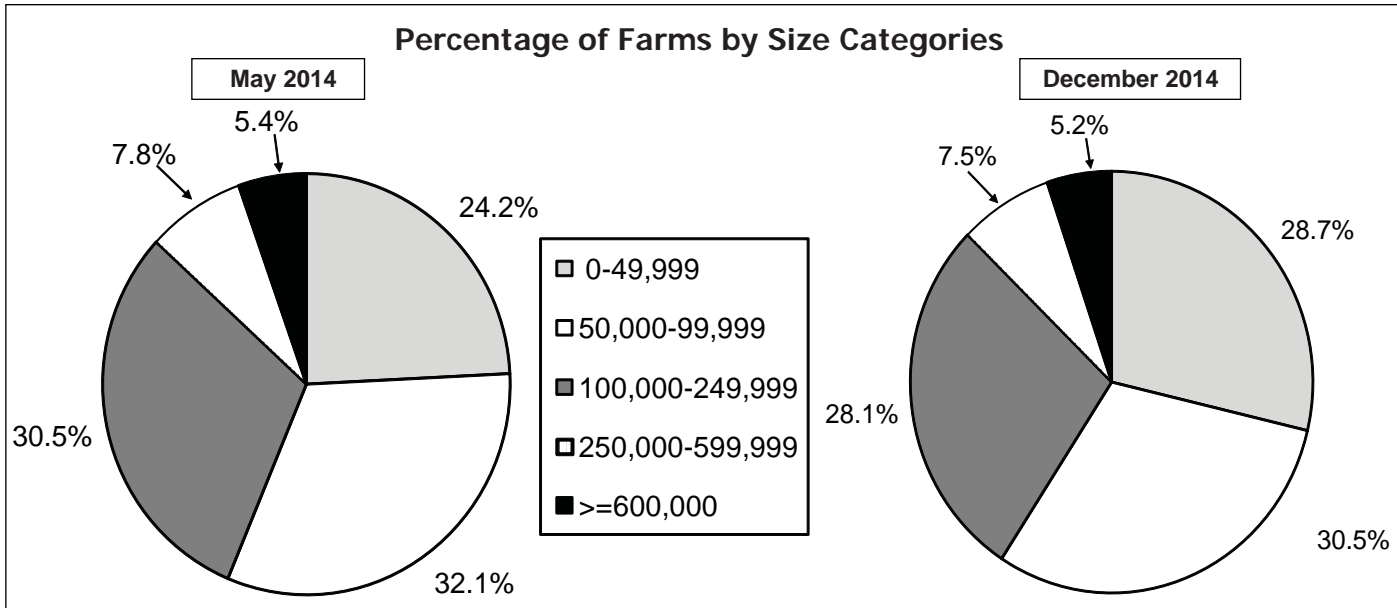

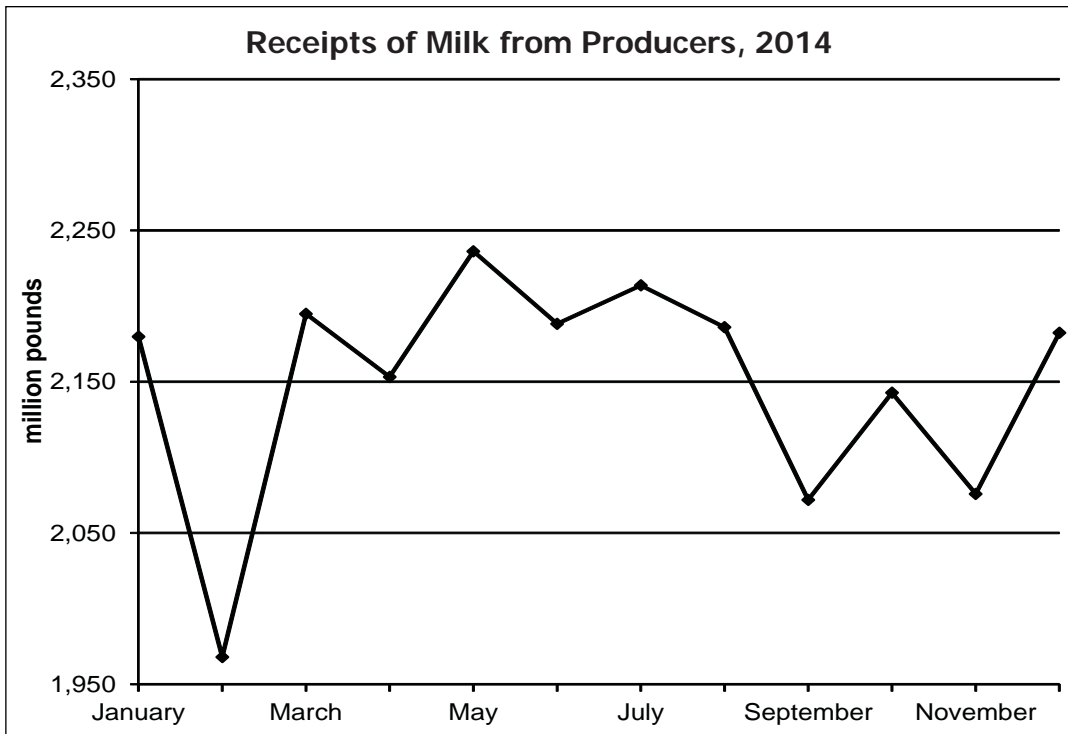

Bulletin Highlights — 2014

January

Milk production in all federal orders was compared in 2013. The Northeast Milk Marketing Area was the second largest of the federal orders in total volume of milk pooled and number one in Class I, II, and IV volume. Class volumes, component tests, and prices were compared. A table showed producer receipts by class and average component tests by federal order.

A summary of the 2013 market service program was discussed. An overview of the calibration program and checks/calibration results was given. A chart illustrated tank checks and calibrations by tank size for 2013.

A pool summary for all federal orders was given in a table for January–December, 2012 and 2013.

February

The total U.S. milk production increase was lower than in previous years, only increasing 0.6 percent in 2013. The top ten milk-producing states combined production only rose 0.5 percent. Milk production in the Northeast milkshed increased 1.6 percent in 2013, more than double the U.S. average. Nationally, the number of milk cows decreased a slight 0.1 percent, while average milk production per cow (MPC) grew 0.7 percent nationally. For the first time since 1995, New York's MPC was above the national average. A table showed the top ten states ranked by milk production for 2013.

A market outlook for 2014 was forecasted. Based on the Chicago Mercantile Exchange (CME) futures the statistical uniform price (SUP) was predicted to average \$22.85 per hundredweight (cwt) for the year for the Northeast Order at Boston, Massachusetts. Factors of the production and price relationship, and the role of exports were discussed. Accompanying charts displayed the relationship between U.S. milk production and the SUP for 2000 through 2014, and the percent of U.S. milk production exported from 2003 through 2014.

March

The components that contribute to the SUP were explained. A chart showed the 2013 annual average contributions to the SUP consisting of the three components (butterfat, protein, and other solids) and the producer price differential (PPD). Another chart illustrated the contribution percentage of components to the SUP from 2000 through 2013.

The 2014 Farm Bill signed in January 2013 included language extending the Dairy Forward Pricing Program under Federal Milk Marketing Orders through September 30, 2013. An extension was signed renewing the program's authority and allowing contracts to be entered into through September 30, 2018, with all terms of the contracts expiring September 30, 2021.

Price variability has been lower while prices have been at higher levels. The SUP at the Boston, MA, differential zone has averaged above \$18.50 per cwt all but two years since 2007. A chart illustrated variability in SUP, as measured by range from high to low, from 2007 through 2014.

A pool summary for all federal orders was given in a table for January–March, 2013 and 2014.

April

Under federal order provisions the Class I price is set by the higher of the Class III or Class IV advanced skim milk pricing factor. Charts presented the uniform price with and without higher of pricing at the Suffolk County (Boston) base location and product prices used in advanced prices from January 2012 through March 2014.

The results of the November 2013 biennial container sales survey for the Northeast Milk Marketing Area were reported. A chart illustrated sales by container size for November 2013.

May

Product price levels for cheese and nonfat dry milk that had pushed the Northeast Order uniform price to an all time high of \$25.46 per cwt for April 2014 have since softened. A discussion was held giving a perspective on the level of prices to expect; looking ahead at CME commodity future prices; and milk production in the Northeast and U.S. exports. A chart showed Agricultural Marketing Service National Dairy Product Sales Report (NDPSR) prices for the first five months of 2014.

The top ten counties on the Northeast Order accounted for 33.5 percent of all milk pooled in 2013, the same percent as in 2012. A map illustrated milk production, number of producers, and average daily deliveries per producer in selected U.S. counties for 2013.

June

During June 2014 a record high volume of milk

was pooled on the order for the month; however, less was utilized in Class I. The impact of declining Class I utilization on the SUP, along with a rough projection of the volume of Class I pounds, was discussed. A chart illustrated utilization for all four classes on a per day basis from January 2011 through June 2014.

Northeast class utilization changes from last year and five years ago were compared to the current year. A table showed utilization for selected products for January through June 2014 versus 2013 and 2009.

A pool summary for all federal orders was given in a table for January–June, 2013 and 2014.

July

Northeast Order total pooled milk receipts decreased 0.6 percent in the first 6 months of 2014. National milk production was discussed and Northeast production was compared to milk receipts. A map illustrated the year-to-year percent change in milk production for selected states from January through June 2014.

The number of “large farms” pooling milk on the Order has increased when comparing May, 2006 to 2014. Accompanying charts presented the proportion of milk pooled and farms, by size category for May, 2006 through 2014.

The shipping percentage was reduced from 20 to 15 percent for the months of September, October, and November 2014.

August

Since 2000, protein, butterfat, and other solids test levels of producer receipts have increased. Accompanying charts displayed average protein, butterfat, and other solids tests by farm size for 2006 through 2013.

The price for Grade AA butter hit a record-high on the CME. Butter’s effect on pay prices, other CME commodity prices, and predictions were discussed. A chart illustrated CME Grade AA butter prices for January 3, 2000, through September 16, 2014.

September

The Class III price exceeded the Class IV price for a second time since January 2013. Estimates of where prices are expected to head into 2015, along with market factors, were given. Charts illustrated Class III and IV prices, from January 2013 through projected 2015, and NDPSR product prices from January 2013 through September 2014.

Changes in utilization of milk products and cream by pool plants for the first nine months of 2014 was compared with last year and five years ago.

A pool summary for all federal orders was given in a table for January–September, 2013 and 2014.

October

Northeast Order Class IV utilization rose 25.7 percent from January through October 2014, when compared to the same time period in 2013. A chart displayed monthly Class IV utilization for 2014 compared to previous record-setting months.

The October 2014 PPD at the Boston, MA, location was \$0.53 per cwt. Negative PPD’s occurred in differential zones of \$2.70 or lower. The scenarios for these results were explained.

Significant changes in where milk is produced in the Northeast and where it ends up during the past five years were discussed. Maps illustrated percent change in pooled milk receipts at selected differential zones and milk production for selected states for 2009 through 2014.

November

The Northeast Order uniform price was forecasted to average over \$24.00 per cwt in 2014. Demand and supply factors were analyzed for 2014, and forecasted for 2015. Charts illustrated U.S. milk production per day from January 2012 through October 2014, and actual and projected USDA’s milk, corn, and diesel prices for 2009 through 2015.

A calendar showed the 2015 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

December

Selected Northeast Order statistics for 2014 were summarized, and a table compared the Order’s pool statistics for 2013 and 2014.

The December Class I price of \$25.78 per cwt was \$7.98 above the December Class III price, the largest price spread since January 2009. A chart illustrated NDPSR prices used in Class I and Class III pricing for December 2014.
